If a school board has violated the Open Meetings Law, a court can: (1) declare that the school board violated the law; (2) declare void the action taken in violation of the law; (3) order the school board to participate in a training session conducted by the Committee on Open Government; and/or (4) award attorneys fees to the successful party.

Open Meetings - Missouri

Open meetings and executive sessions. (a) Every meeting of a public body shall be open to the general public, except that an executive session of such body may be called and business transacted thereat in accordance with section one hundred five of this article.

New Jersey's current administrative code, N.J.A.C. 5:20-1.2, requires that a condominium provide

"adequate notice" of each board meeting at which binding decisions of that board are to be made. This code provision provides that "adequate notice" is "written notice, at least 48 hours in advance, giving the time, date, location and, to the extent known, the agenda of any regular, special, or ...

Except as provided by subsection b. of this section all meetings of public bodies shall be open to the public at all times. Nothing in this act shall be construed to limit the discretion of a public body to permit, prohibit, or regulate the active participation of the public at any meeting, except that a municipal governing body and a board of education shall be required to set aside a portion of every meeting of the municipal governing body or board of education, the length of the portion ...

Section 10:4-12 - Meetings Open To Public; Exceptions ...

The Tennessee Open Meetings Act requires notice of the meeting itself but does not specifically require notice of the content of the meeting. Tenn. Code Ann. § 8-44-103. Accordingly, a governing body is not required to post a meeting agenda as part of the public notice required under the Tennessee Open Meetings Act. *Lewis v. Cleveland Mun.*

Tennessee Open Meetings Act FAQs - TN Comptroller

(4) A meeting of a public body which is recessed for more than 36 hours shall be reconvened only after public notice has been posted at least 18 hours before the reconvened meeting. 10. At their first meeting of the calendar or fiscal year, each board must set the dates, times, and places of the board's regular meetings for the coming year.

OPEN PUBLIC MEETINGS ACT - New Jersey Foundation for Open ...

The Open Meetings Act (Government Code, Chapter 551) provides that meetings of governmental bodies must be open to the public (except for expressly authorized executive sessions). Both state and regional agencies file notices of open meetings with the Secretary of State's office. State agencies are governmental bodies with statewide jurisdiction.
